(57) Abstract :

The present invention relates to a novel Ayurvedic herbo-mineral formulation designed for cancer management and supportive oncology care. The formulation comprises a synergistic combination of classical bhasmas, pishtis, and herbal extracts, including SwarnaBhasma, RasSindoor, RasKapurBhasma, TamraBhasma, HeeraBhasma, AbhrakBhasma, PannaPishti, PravalPishti, ShuddhGandhak, GiloyTatva, Shilajit, Long, ShwetMirch, and ParadBhasma. Each component is processed using standardized Ayurvedic purification, incineration, and extraction techniques to ensure safety, reproducibility, and enhanced bioavailability. The formulation exhibits multi-targeted therapeutic effects, including immunomodulation, antioxidant protection, cytoprotection, and anti-proliferative activity, making it suitable for prevention, management, and adjunctive treatment of cancer. It can be administered in oral dosage forms such as powders, tablets, capsules, or suspensions, ensuring patient compliance and therapeutic versatility. The unique combination of bhasmas, pishtis, and herbal extracts provides a synergistic effect, addressing limitations of prior art such as limited efficacy, toxicity, and lack of standardization.
